#### WHY APPLY FOR A U.S. MINOR PASSPORT?

## Every child, regardless of age, needs a passport to travel abroad







### WHO NEEDS TO COME TO THE APPOINTMENT?

The child

Both natural parents\*



### \*IF ONE PARENT/GUARDIAN CANNOT BE PRESENT AT APPOINTMENT

**■**The absent parent must:

- Complete a signed, <u>notarized</u> <u>DS-3053</u>:
   Statement of Consent form (only valid within <u>90 days</u> of signing)
- Submit a photocopy of the front and back of the same photo ID presented to the notary public

### \*IF ONE PARENT/GUARDIAN HAS SOLE AUTHORITY

- If one parent/guardian is deceased, the other parent must bring:
  - The official, certified death certificate

- If one parent/guardian has sole authority, they must bring:
  - A court order or judicial declaration of incompetence of the non-applying parent

- All documents should be in original form no photocopies will be accepted
- 1. Evidence of U.S. Citizenship
- 2. Evidence of Parental Relationship
- 3. Photo Identification
- 4. Parental Consent
- 5. Passport Photo
- 6. Application Form
- 7. Passport Fees

### 1. WHAT DOCUMENTS CAN PROVIDE EVIDENCE OF CITIZENSHIP?

- Certified Birth Certificate
- Certificate of Citizenship
- Certificate of Naturalization



- Consular Report of Birth Abroad (CRBA)
- Previous undamaged U.S. passport

### 2. WHAT DOCUMENTS CAN PROVIDE EVIDENCE OF PARENTAL RELATIONSHIP?

■U.S. birth certificate

Foreign birth certificate

CRBA

Divorce/Custody decree

Adoption decree



### 3. WHAT COUNTS AS PHOTO IDENTIFICATION?

Parents (and children if they have one) must present a valid photo identification document. Examples include:

A valid Driver's License

An Argentine DNI



A current, undamaged U.S. passport

### DOES MY CHILD NEED ADDITIONAL PHOTO IDENTIFICATION?

- If your child is renewing a passport, and your child's first passport has a baby picture, you will need to provide age progression photos
- Amount necessary is <u>1 picture per year aged</u> since original passport photo









#### 5. PASSPORT PHOTO

Must submit a recent passport photo

In color
Passport size (5 cm x 5 cm)
White background

**■**DS-11 - Application for a U.S. Passport


■DS-3053 (if only one parent/guardian attends

the appointment)



### 6. DO I NEED A SOCIAL SECURITY NUMBER?

- ■DS-11 form asks for your social security number
  - If child does not yet have their social security number,
     please submit the <u>SS-5 Application for a Social Security</u>
     <u>Card</u> along with your passport application



#### 7. FEES

\$115 for the passport application

(Additional delivery fees through DHL)



#### PASSPORT DELIVERY VIA DHL

- All non emergency passports are retuned via DHL
- Applicants must visit DHL at:
  - \*Av. Cabildo 1209, Belgrano, CABA
  - \*25 de Mayo 447, Microcentro, CABA

- We recommend going before your appointment.
- Bring the airway bill sheet with tracking number.
- Visiting DHL after appointment might delay delivery
- Delivery typically takes 3 weeks
